## Gist of Proceedings of the 32<sup>nd</sup> Annual General Meeting of Primax Fiscal Services Limited

### 1. Date, Time and Venue of the Meeting

The 32<sup>nd</sup> Annual General Meeting of the Company was held today i.e. on Tuesday, 26<sup>th</sup> September 2023 and the meeting commenced at 11:00 a.m. at 33A, Jawaharlal Nehru Road, Chatterjee International Centre, 8<sup>th</sup> Floor, Room No. A-10, Kolkata- 700071, West Bengal. The meeting got closed at 11:15 a.m. on the same day.

### 2. Brief details of items deliberated at the Meeting and result thereof

- Mr. Pramod Kumar Jhunjunwala, Director, chaired the proceedings of the Meeting.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman informed that remote e-voting commenced at 9:00 a.m. on 23<sup>rd</sup> September 2023 and ended at 5:00 p.m. on 25<sup>th</sup> September 2023. Facility for voting through ballot paper was also provided at the meeting venue.
- The following items of business as set out in the Notice calling the Meeting were put for Shareholders' approval –

#### Ordinary Business

- (i) Consideration and adoption of Audited Accounts of the Company for the financial year ended 31<sup>st</sup> March 2023 along with Auditors' Report and Directors' Report thereon;
  - (ii) Re-appointment of Mr. Dibyendu Saha (DIN: 01916496) as Director, who retires by rotation.
  - (iii) Re-appointment of M/s Agarwal Maheswari & Co., Chartered Accountants (FRN. 314030E), as the statutory auditors of the Company, to hold office from the conclusion of this AGM till the conclusion of next Annual General Meeting to be held in the year 2025.
- Clarifications were provided by the Chairman to the queries raised by the members at the meeting.
  - The Chairman informed the members that Mr. Babu Lal Patni (FCS 2304), Practicing Company Secretary was appointed as the scrutinizer for the purpose of scrutinizing the remote e-voting and ballot process at the AGM venue.
  - The Chairman informed the Members that the result of voting will be placed on the Company's website [www.primaxfiscal.com](http://www.primaxfiscal.com) as well on the CDSL's website. Report of the result will be sent to Calcutta Stock Exchange.
- ### 3. Manner of approval
- Pursuant to the provisions of the Companies Act, 2013 and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided remote e-voting facility to its members to cast votes electronically, on all the resolutions set out in the Notice.
  - Further, the facility for voting through ballot paper was made available to the members who were present at the meeting and had not cast their votes by remote e-voting.
