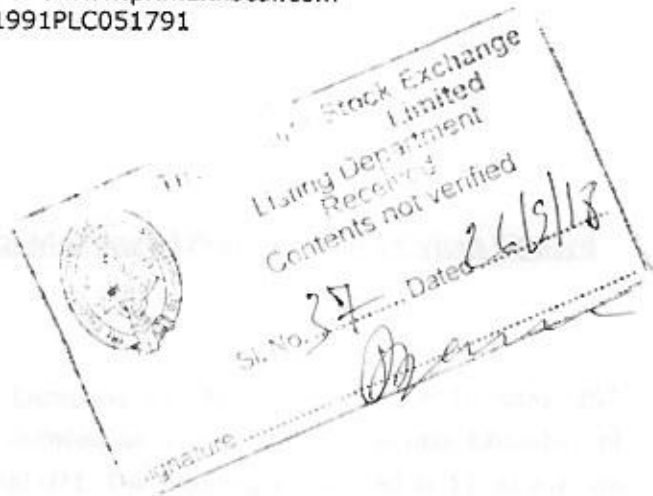

Gist of Proceedings of the 27th Annual General Meeting of Primax Fiscal Services Limited

1. Date, Time and Venue of the Meeting

The 27th Annual General Meeting of the Company was held today i.e. on Tuesday, 25th September, 2018 and the meeting commenced at 11:00 a.m. at Calcutta Chamber of Commerce, 18-H, Park Street, Kolkata- 700 071. The meeting got closed at 11:30 a.m. on the same day.

2. Brief details of items deliberated at the Meeting and result thereof

- Sri Pramod Kumar Jhunjunwala, Director, chaired the proceedings of the Meeting.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman informed that remote e-voting commenced at 9:00 a.m. on 22nd September, 2018 and ended at 5:00 p.m. on 24th September, 2018. Facility for voting through ballot paper was also provided at the meeting venue.
- The following items of business as set out in the Notice calling the Meeting were put for Shareholders' approval –

Ordinary Business

- (i) Consideration and adoption of Audited Accounts of the Company for the financial year ended 31st March, 2018 along with Auditors' Report and Directors' Report thereon;
- (ii) Re-appointment of Ms. Mamta Nahar (DIN: 07129123), a Director who retires by rotation and being eligible, offers herself for reappointment;

Special Business

- (iii) Appointment of Mr. Pankaj Kakra (DIN: 08021936) as an Independent Director for a period of 5(Five) consecutive years w.e.f the date of this AGM.

(iv) Appointment of Mr. Dibyendu Saha (DIN: 01916496) as a director liable to retire by rotation.

- Clarifications were provided by the Chairman to the queries raised by the members at the meeting.
- The Chairman informed the members that Sri Babu Lal Patni (FCS 2304), Practicing Company Secretary was appointed as the scrutinizer for the purpose of scrutinizing the remote e-voting and ballot process at the AGM venue.
- The Chairman informed the Members that the result of voting will be placed on the Company's website www.primaxfiscal.com as well on the CDSL's website. Report of the result will be sent to Calcutta Stock Exchange.

3. Manner of approval

- Pursuant to the provisions of the Companies Act, 2013 and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided remote e-voting facility to its members to cast votes electronically, on all the resolutions set out in the Notice.
- Further, the facility for voting through ballot paper was made available to the members who were present at the meeting and had not cast their votes by remote e-voting.
- No shareholder opted for voting through ballot paper.
- The results of e-voting will be declared after receipt of Scrutinizer's Report. All the resolutions set out in the Notice calling the Annual General Meeting if passed with requisite majority shall be deemed to be passed on the date of the Annual General Meeting i.e. 25th September, 2018.
